The Zoning Administrator may establish such addition conditions as deemed necessary to ensure land use compatibility and to minimize potential impacts on nearby uses.

The approval of this application shall not be construed as approval to violate any City Ordinance or Code adopted by the City of Sioux Center. It is the responsibility of the applicant to comply with any requirements that may be required by the City of Sioux Center.

Determination:

- The temporary use will not impair the normal, safe, and effective operation of a permanent use on the same site
